Further to Councillors being told that permission had been given for boys to ride their bikes in the field to the right of the bridleway until a new crop was sown – possibly in the spring – a member of the public voiced her concerns regarding this issue. The boys are apparently pushing their motor bikes to the bridleway path and then riding them down the path to gain access to the field.

This is the suggested amended minute:

Further to Councillors being told that permission had been given for boys to ride their motor cycles in the field to the right of the bridle path until a new crop was sown – possibly in the spring – a member of the public voiced concern regarding the boys riding their motor cycles along the bridle path to gain access to the field and, in doing so, presented a real threat to the safety of horse riders, walkers with children/dogs etc.
